## Privacy, access, and security

- PanelDesk applies a POPIA-first approach. For workshop data entered into the service, the workshop remains the responsible party and PanelDesk acts as an operator where applicable.
- Customer-facing quote, invoice, and clearance links use token-validated access so customers do not need public login accounts.
- Operational controls described publicly include authentication checks, permission-based access controls, rate limiting, scoped upload controls, audit logging, webhook signature verification, and service backup practices.
